


LOCATION AND CLIMATE

ABOUT COLLEGE

Based on the principles of excellence and 'caring wisdom,' Ramkumari College of Veterinary Sciences managed by Prof. S. Karan Shiksha Samiti, is one the pioneer of private veterinary institutions in India.

Ramkumari College of Veterinary Sciences (RCVS), located in the Mukundgarh Mandi, Haritage Area, has a picturesque beauty. The premises of college are spread over an area of 35 acres of land, situated on Jaipur-Pilani State highway No.85, The college is about 127 kms towards Jaipur, from the Jhunjhunu district headquarter along with a large Livestock Farm Complex spread over several acres. RCVS has started B.V.Sc. & A.H. degree this year, 2025, with the permission of Veterinary Council of India (VCI) and Rajasthan University of Veterinary and Animal Sciences (RAJUVAS).

Ramkumari College of Veterinary Science aims to extend the scope of learning through a holistic approach that accommodates diverse linguistic, scientific and cultural traditions.

The college has started its first academic session of B.V.Sc. & A.H. with 80 students in its first batch. Since 2019 the college has been relentlessly working to achieve its motto, by virtue of which till date four batches of students have completed their Veterinary diploma and are engaged in various sectors. The RCVS will maintain highest standard in B.V.Sc. & A.H. degree program by providing best training program through highly qualified faculty. Given the tradition of teaching excellence and training that RCVS has developed and enhanced in a short span of time, it is well poised to continue on its path of enviable growth and success through its B.V.Sc. & A.H. degree program.

The college has made faster progress in developing infrastructure and teaching facilities and has always maintained the high profile for imparting veterinary education. The college is strictly following the guidelines of Minimum Standards of Veterinary Education regulation (MSVE-2016), of Veterinary Council of India., New Delhi. The main campus building provides an excellent study environment, social space and good facilities. The laboratories are well equipped; the library is spacious, well-furnished and maintaining good number of both text and reference books, and journals. The hands on trainings, in Veterinary Clinical Complex (VCC) to students for treating the indoor and outdoor patients are of very high standard. Practical training in livestock management and production, that includes training in fodder production is performed in Livestock farm complex (LFC). On LFC is maintaining about 10 species of animals and birds, huge agricultural land having varies of fodders is able to provide adequate knowledge and practical education to the students making them more confident on the student.

Adequately qualified and skilled teaching faculty, spacious and well-ventilated lecture halls with latest teaching aids, modern means of communications, well-furnished hostels for boys and girls, play grounds, buses, 24 hours electricity and water supply facility and lush green lawns are the salient features of this college.



The Degree course of Veterinary Sciences is of 5 years & 6 months.

The degree is abbreviated as

B.V.Sc. & A.H.

(Bachelor of Veterinary Sciences And Animal Husbandry)

1st YEAR PROGRAM

During this one year, students have to spend time in various departments viz. Veterinary Anatomy, Veterinary Physiology & Biochemistry and Livestock Production Management (LPM).

2nd YEAR PROGRAM

During this year, students will go through courses and practicals of four departments viz. Veterinary Microbiology, Veterinary Pathology, Animal Genetics & breeding and Animal Nutrition.

3rd YEAR PROGRAM

During this year, students will gain knowledge from Veterinary Pharmacology and Toxicology, Veterinary Parasitology, Veterinary Public Health and Epidemiology, Veterinary & Animal Husbandry extension Education, Livestock Products Technology, Veterinary Clinical Practices-1 and Livestock Farm Practices.

4th YEAR PROGRAM

The duration of this programme will be one year six months. Students will be trained in clinical subjects viz. Veterinary Surgery, Veterinary Medicine, Veterinary Gynaecology & Obstetrics and Veterinary Clinical Practices-II

5th INTERNSHIP PROGRAM

Internship is compulsory and will be of one year. Students will provisionally registered by Veterinary Council of State and will devote full time in providing clinical services under the supervision of the teachers.





ADMISSION PROCEDURE

DEGREE OFFERED

The **B.V.Sc. & A.H.** degree course is five and half years duration (four and half year course and 12 months compulsory internship as per VCI recommendations)

ELIGIBILITY (AS PER VCI NORMS).

1. The candidate must have attained or will attain the minimum age of 17 years before 31 December of that year.
2. There shall be relaxation of maximum age by 5 years for scheduled caste or scheduled tribes or other backward class candidates.
3. A candidate under general category for admission to the Bachelor of Veterinary and Animal Science Degree course shall have to qualify in each of the subjects of English, Physics, Chemistry and Biology from a recognized/ approved board of School examinations and obtained 50% marks in aggregate of these subjects.
4. In respect of candidates belonging to the scheduled caste or the scheduled tribes or other special categories of students as specified by the Govt. from time to time, much required for admission shall be 5% less than that prescribed for general category i.e., 47.5%.
5. In case result of the qualifying admission has been declared publicly but the certificate has not been issued by the concerned Board/University, such candidates shall have to produce a certificate (Annexure III) from the Head of the Institution last attended.
6. Candidates appearing/ appeared in the qualifying exam i.e., Senior Secondary or its equivalent recognized examination in that year and whose result has not been declared by the last date of submission of Admission Form may also apply but they shall not be eligible for admission to B.V.Sc. & A.H. course if they, at the time of counselling, do not produce documentary proof of passing qualifying exam with the required percentage of marks as applicable to them.

NEET-2025 (UG)/RPVT :

7. All the candidates seeking admission to the B.V.Sc & A.H. Degree Programme must appear in the NEET (UG) 2025
8. Same marks in the NEET-2025 (UG) or otherwise- in case of two or more candidates scoring same marks in the NEET-2025 (UG), the merit would be decided on the basis of aggregate marks obtained in the subjects of English, Physics, Chemistry and Biology of 10+2 examinations. If still, there is a tie then the candidate senior in age will be considered higher in the Merit.

GENERAL RULES :

1. The competent authority reserves the right to reject any admission for reasons to be recorded.
2. All the state quota seats for B.V.Sc. & A.H. programme are only for Rajasthan resident candidates
3. Admission on Management quota seats will be made on the basis of all India Merit List of NEET-2025 (UG) for which the candidate from all over country including Rajasthan will be eligible.
4. The candidates who would have been allotted seats are to report for document verification and other admission formalities as per the schedule to be uploaded on the College website.
5. The candidate shall have to pay fees and other charges there and then, otherwise the seat will be declared vacant. If any candidate after completion of admission formalities does not deposit the required fee, his/her candidature will be cancelled. Also if any candidate remain absent at the time of document verification, fee deposition, he/she will not be considered in the subsequent counselling(s) even if he/she is higher in merit. Further, if a candidate refuses to accept right of admission on his/her turn, he shall lose his/her The candidates are required to bring all the original documents, two recently taken photos and two sets of self attested photocopies of documents etc at the time of document verification failing which they shall be refused admission. The original documents of the admitted candidates shall be retained by the Dean's office & temporarily provided to the candidate on a written request week or upto one day before the subsequent counselling, whichever is earlier and if not returned back by the date committed, admission of that



candidate shall stand automatically cancelled. This document will be returned to the candidate after the completion of verification process.

7. After deposition of fees and other charges, the candidate shall get themselves medically examined, submit medical certificate on the same day in the Dean's office and complete the registration on the same day. The fees deposited by the candidate, who is medically unfit shall be refunded and his/her admission shall automatically stand cancelled. The admission of those candidates, who fail to complete any of the admission formalities, shall stand cancelled and on the request of the candidate the dues debt shall be refunded as per rules.

The completion of admission process involves the following-

(I.) Verification and submission of all the original documents along with self attested photocopies as mentioned in serial no. 9 at the time of document verification.

(II.) Deposition of fees.

(III.) Medical examinations.

Original and two sets of self attested photocopies of the following documents are required to be deposited at the time of Document verification and failure to produce any of the original document shall make the candidate ineligible for the Admission:

10. The record related to admission process/ counselling shall be destroyed after six month of last counselling/cut off date except that related to any pending court Case.

11. A candidate aggrieved by any decision may appeal within three days to the competent authority who will examine the application with reference to the rule and Regulations. Decision of the Chairman, Prof. S.Karan Shiksha Samiti, in the matter, shall be final.

12. Admission remains provisional. Documents submitted by the candidates shall be checked/got verified/reverified from the concerned Board/University at any time during course of the study. If at any stage, any certificate is found fake or not equivalent by board of school examination, or any other Board, admission will be cancelled and Legal action will be initiated.

Regular Seats (40 No.): Admission are made through RPVT (Rajasthan Domicile only) as per rules and regulation made by Rajasthan University of Veterinary and Animal Sciences (RAJUVAS) Bikaner, Rajasthan.


LIBRARY (E-Library & Software)

DEPARTMENTS

VETERINARY ANATOMY

Sound knowledge of anatomy and physiology is an essential basis for the effective clinical treatment of companion animals and farm animals alike. Ramkumari College of Veterinary Science provides comprehensive and detailed classes of anatomy and physiology of all the animals by the Department of Veterinary Anatomy. It has the sole purpose to make students acquainted with the form and structure of various animal species and to facilitate them to learn the basic concepts and fundamentals of veterinary anatomy and histology that serve as the foundation for the further veterinary education. To fulfil these criteria, the department has well-equipped anatomy labs which serve as the knowledge center for students to know the animals by various structures and skeletons of all sorts of animals. The embalming room has the facility for short long-term storage of dissected specimens and articulated and disarticulated skeletons of several livestock species.



VETERINARY PHYSIOLOGY & BIOCHEMISTRY

Department of Veterinary Physiology & Biochemistry is one of the basic departments. The primary mandate of the department is to impart training to undergraduate (B.V.Sc. & A.H.) & Diploma (VLDD) students in the fields of general, experimental, and specialized areas of veterinary physiology and biochemistry. Physiology and Biochemistry are fundamental to an understanding of modern life science and all the students need to study these subjects as major subsidiaries to their main disciplines Veterinary and Animal Science. This department has established laboratories with sophisticated equipment for Electrocardiography; Hematology, Blood Biochemical Analysis, and Mineral Estimations. The ultra-modern types of equipment are used for undergraduate and postgraduate teaching. Ramkumari College of Veterinary Science possesses state-of-the-art facilities for students including an Automatic Hematological Analyzer, Spectrophotometer, Viscometer, Urinometer, Meteorological instruments (Max and Min thermometer, Wind Vane, Flame Photometer, Paper Chromatography System, Fume-hood, Blood Chemistry Semi Auto-Analyzer, etc.)





LIVESTOCK PRODUCTION MANAGEMENT

The Department of Livestock Production Management is one of the major parts of the animal sciences department. The department is involved in the teaching of Diploma and Undergraduate courses. Besides this, the department conducted training programs and provided technical guidance to the farmers through different extension activities, radio, and TV programs. The department has established a breed museum with good photo photographs and three-dimensional models of important breeds, and housing models of various species of livestock including cattle, buffalo, sheep, goat, swine, rabbit and horse.



ANIMAL GENETICS AND BREEDING

The department has excellent laboratory facilities and adequate infrastructure as per VCI norms. The department is engaged genetics and computer application.

Department give practical training to students in the field of biostatistics using computer for tabulation of scientific data and interpretation and for this modern computer laboratory has been established.





VETERINARY MICROBIOLOGY

The Department of Veterinary Microbiology has been created with the aim of identifying and controlling the infectious diseases of livestock through quality education. The practical training in department includes culture isolation, characterization of different micro-organisms and serological tests. The department is well equipped with all basic modern equipments including laminar flow, BoD, Co₂ incubator, inverted microscope, immunoelectrophoresis apparatus etc. Modern equipments for teaching molecular techniques PCR, ELISA, blotting, refrigerated centrifuge, ultrasonicator are also available. There are three laboratories set up as per MSVE 2016 guidelines viz Immunology and Serology and Veterinary Bacteriology & Mycology laboratories.



VETERINARY PATHOLOGY

The sound knowledge of etiologies and diagnosis of disease is most for treatment and prevention of various animals in livestock and poultry. The mandate of the department is to teach pathology of disease progression and practical training for identification of gross lesions on post-mortem examination, microscopic and histological changes for diagnoses of various diseases.

The Department is well equipped and offers some of the best quality facilities for teaching under graduate classes including for tissue processing, histopathology, clinical pathology for testing clinical samples of various body fluids and also has facility for post-mortem examination of large and small animals. There is a museum having specimens depicting gross lesions of various animal diseases & poultry diseases. Various instruments available in the department include a semi-automated rotary microtome, Spectrophotometer, binocular microscopes, water bath laminar flow, Autopsy table, Phase contrast microscope, cryostat and also facility of microscopes with attached digital cameras of high resolutions for displaying histopathological slides and with microphotography.





ANIMAL NUTRITION

The department offers undergraduate education in the field of animal nutrition including various aspects of energy and protein requirement for better animal production in terms of growth. The department is full-fledged with human resources, infrastructure and laboratory facilities. The laboratory contains all the instruments, apparatus, glassware and chemical required for undergraduate classes.

The department has different laboratories for feed and fodder analysis and energy metabolism. Modern apparatus like hot air oven, muffle furnace, desicator, kjeldhals digestion system, Soxhlet apparatus and water bath are available for teaching students.



LIVESTOCK FARM COMPLEX (LFC)

Adequate numbers of livestock species viz. cattle, buffalo, sheep, goat, pig, horse, camel and poultry are maintained in our LFC. This department provides practical training to students in different aspects of management, feeding, housing, breeding and care of various farm animals. The Fodder farm is well supported by fertile and well irrigated land for fodder production. Solar power operated tube wells have been installed to conserve the energy. A modernized dairy shed has been established in the farm complex. The milking of milch animals is done by milking machines with the least human involvement for clean milk production. The milk produced in the farm is utilized for the student's





VETERINARY CLINICAL COMPLEX (VCC)

This Department-cum-Hospital provides the students an opportunity to get them trained to treat various types of clinical cases; both outdoor and indoor patients. Large number of outdoor patients come from the nearby villages daily, that provides an adequate learning opportunity to the students. This department provides 24x7 days OPD service and also provides emergency indoor services. This complex is well equipped with various ultramodern equipments such as C-Arm X-Ray machine. ultrasonography machine, otoscopes, laryngoscopes, biochemical analyzers, operation theatre for large and small animals, retiring rooms for patient owners, and many other such facilities, Institution provides free technical advice and few medicines to the visiting clients/patient owners.



AMBULATORY SERVICES

The college is providing an ambulatory service for free treatment and consultancy at the doorsteps of the farmers of nearby villages. It also provides an opportunity to the students to cope up with the situations to treat the animals in field conditions where specialized services are not available





RULES REGARDING PREVENTION OF RAGGING

Title, Commencement and Applicability:

The College has adopted the UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009 as well as the directions of the Hon'ble Apex Court.

They shall apply to all the students enrolled in B.V.Sc & A.H. Degree Programme or any other category of courses in which instruction/education is imparted by the College.

What constitutes Ragging:-

Ragging constitutes one or more of any of the following acts:

- i) Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student;
- ii) Indulging in rowdy or undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student;
- iii) Asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student.
- iv) Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher.
- v) Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
- vi) Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students.
- vii) Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person.
- viii) Any act or abuse by spoken words, e-mails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student;
- ix) Any act that affects the mental health and self confidence of a fresher or any other student. With or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student.

Administrative action in the event of Ragging:-

1. The Dean/Principal shall punish a student found guilty of ragging after following the procedure and in the manner prescribed hereinunder : The Anti- Ragging Committee of the college shall take an appropriate decision, in regard to punishment or otherwise, depending on the facts of each incident of
 - i. Ragging and nature and gravity of the incident of ragging established in the recommendations of the Anti-Ragging Squad.
 - ii. The Anti-Ragging Committee may, depending on the nature and gravity of the guilt established by the Anti-Ragging Squad, recommend, to those found guilty, one or more of the following punishments, namely.
 - a) Suspension from attending classes and academic privileges.
 - b) Withholding/withdrawing scholarship/ fellowship and other benefits.
 - c) Debarring from appearing in any test/ examination or other evaluation process.
 - d) Withholding results.
 - e) Debarring from representing the institution in any regional, national or international meet, tournament, youth festival etc.

- f) Suspension/expulsion from the hostel.
- g) Cancellation of admission.
- h) Rustication from the institution for period ranging from one to four semesters.
- i) Expulsion from the institution and consequent debarring from admission to any other institution for a specified period.
Provided that where the persons committing or abetting the act of ragging are not identified, the institution shall resort to collective punishment.

1. The appeal shall lie with the Chairman, Micro Vision Society within fortnight from the date of issue of orders.
2. Where in the opinion of the appointing authority, a lapse is attributable to any member of the faculty or staff of the college, in the matter of reporting or taking prompt action to prevent an incident of ragging or who display an apathetic or insensitive attitude towards complaints of ragging, or who fail to take timely steps, whether required under these Rules or otherwise, to prevent an incident or incidents of ragging, then such authority shall initiate departmental disciplinary action in accordance with the prescribed procedure of the institution against such member of the faculty or staff.

Suspension:-

1. After having regard to the nature and gravity of the incident of ragging, the Dean of the College concerned to the students is satisfied that it is necessary/ desirable in the interest of the college to place under suspension, the student found involved in an act of indiscipline, he/she may place such student under suspension. Such suspension will not amount to any penalty having been imposed under the provisions under these rules.
2. Such suspension will debar a student from availing any facility of the college.
